Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

Collaboration with parents, teachers, and school staff through in-person discussions; online or printed surveys; and email input opportunities, provided feedback with the purpose of promoting plan involvement prior to adoption at the May 2021 board meeting. The results of stakeholder feedback and surveys overwhelming identified the need for supplemental instruction and support strategies to 1) accelerate progress to close learning gaps through the implementation, expansion, or enhancement of learning supports by increasing paraprofessional staffing time; assigning an intervention teacher; and offering after school tutoring time; 2) integrated student supports to address other barriers to learning by offering counseling; and 3) training for school staff on strategies to engage students and families in addressing students' social-emotional health and academic needs by continuing PBIS (Positive Behavioral Interventions and Supports) strategies and supports district wide.

A description of how students will be identified and the needs of students will be assessed.

The district will utilize the following assessments to identify students for academic supports:
Students in K-2 will be identified through: teacher evaluation; routine standards assessments; and STAR Early Literacy beginning of year and quarterly assessment
Students in 3-8 will be identified through: teacher evaluation; beginning of year and quarterly STAR assessments in ELA and Math; and spring 2021 SBAC results

The STAR Early Literacy, ELA (English Language Arts) and Math is an assessment program to measure student proficiency and growth. This performance monitoring tools allows the district to measure the effectiveness of evidence-based services by student in order to identify individualized learning growth areas and then formulate the interventions needed to help close these achievement gaps.

In order to identify students' social emotional needs and other integrated supports (health, mental health, school meals, and the after school program), the district will utilize the following:

- 1) Counselor- will conduct risk assessments and initial evaluations to determine the need for ongoing school based mental health in individual and small group settings. Referrals can be made by counselor, teachers, school staff, pupil, parent and administration. The assessment will be ongoing from daily to monthly depending on individual student's need.
- 2) School Nurse- The district has increased the number of days that the nurse will be onsite. Students referrals can be made by teachers, school staff, pupil, parent, administration and counselor and will be assessed regularly on monthly basis.
- 3) School meals- We offer free breakfast and lunches to all students for all school days. No identification or ongoing assessment is needed.
- 4) After School Program- Identifying students for the after school program will be based on the California Department of Education - Expanded Learning Division's guidelines and/or priorities list. Weekly assessments will be conducted.

The adopted Expanded Learning Grant Plan will be posted on the district website and shared at stakeholder meetings. Moreover, the related services available, will be communicated out by site staff to students and families through letters, phone calls, weekly bulletins and our website.

A description of the LEA's plan to provide supplemental instruction and support.

The district intends to offer based on a tiered framework of universal, targeted, and intensive supports on students' needs for academic, social-emotional, and other integrated student support: after school tutor time in the coming year; plans to continue to provide an Intervention Teacher for all grade levels 3-days a week to focus on remediation services based on identified needs and testing results; provide more paraprofessional time to assist with English Learners, students with disabilities and students with learning gaps; and counseling as an integrated student support.

The district will continue to utilize Positive Behavioral Interventions and Support (PBIS) in addition to trauma informed and restorative practices to engage students and promote a positive school climate.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

Hornbrook Elementary School District is coordinating the use of the Expanded Learning Grant (ELO) and other federal ESSER funds by budgeting all funding sources across several categories to best meet the needs of the district, staff, students and community. In 2021-22, the ELO funds are primarily budgeted towards intervention teaching staff; paraprofessional staffing; counseling services; tutoring time; and staff training of PBIS. In 2021-22, the ESSER funds are primarily budgeted towards maintaining operations and continuity of services and continuing to employ existing staff; replace entry doors to improve indoor air quality; technology needs in the classrooms; and mental health services/counselor and nursing supports.

Expanded Learning Opportunities Grant Plan Instructions: Introduction

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education, or charter schools, collectively referred to as Local Educational Agencies (LEAs), that receive Expanded Learning Opportunities (ELO) Grant funds under California *Education Code (EC)* Section 43521(b). Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the

supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.

- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
